

Communal Functions

- Provide public services for manual and mechanized collection of urban solid waste, as well as treatment and final disposal thereof. To state entities authorized to mixed companies, international economic associations, foreign real estate and residences of foreigners.
- Finance the maintenance, repair and replacement of isolated mountain generators served by community services.
- Finance, through the state budget, the conservation, maintenance, repair, construction of streets, bridges, sidewalks, highways, embankments and roads, under the jurisdiction of the (CAP).
- Finance the expense with the budget assigned to pay for the services of water pipes to the population.
- Methodologically address the registration system related to the environmental hygiene of the territory.
- Provide services in cleaning neighborhoods on streets, sidewalks and containers
- Provide cleaning services in fountains, tarjas, parks, solar plants, buildings, to a mixed company, international economic associations, to the diplomatic corps, foreign firm and presentations, real estate
- Collect and wholesale the raw materials and other resources contained in urban solid waste, to the union of raw material recovery companies.
- Provide cleaning services, maintenance and conservation in the areas and banks of rivers where there are tourist services.
- Provide urban solid waste and construction waste collection services to state entities and individuals.
- Execute ETECSA registry cleanings in Foreign Currency.
- Provide obituary services to the population.
- Carry out transfer and other funeral services to foreigners, deceased in the national territory.
- Carry out transfer and other funeral services to the relatives of the deceased to other territories, inside and outside the Province.

- Carry out the promotion, maintenance, conservation and cultural attention of green areas, to the population and state entities authorized to pay, as well as to mixed companies and residences of foreigners.
- Produce and commercialize, in a retail way, natural and artificial flowers, natural and ornamental plants, medicinals and foliage, as well as decoration items and supplies for gardening and flower shops.
- Produce and commercialize wholesale decorations, flower settings, arrangements, florals, natural plants, ornamentals to state entities. a mixed company, international economic associations, firm and foreign representations, real estate and residences of foreigners.
- Carry out projection design and budget calculation for investments in green areas, as well as for state entities.
- Marketing technology for the use and management of elements of florists and ornamental plants.
- Provide specialized advice, technical and professional training in this activity.
- Produce and commercialize the earthworm humus and compots in Foreign Currency in joint ventures, international economic associations, the diplomatic corps, foreign real estate firms and presentations and residences of foreigners to state entities.
- Provide tree trimming and felling services to authorized state entities and population to a mixed company, international economic associations, firm and foreign representations, real estate and residences of foreigners.
- Provide floral messaging services. In the case of international messaging it will only be to authorized entities, as well as its collection in foreign currencies.
- Execute the charges to the entities and enjoy the equipment in the playgrounds previously approved, without understanding them to new entities, in case of foreigners,
- Provide guide and information services in parks and cemeteries to foreigners.
- Purchase and Marketing of ceramic objects in retail in national currency to the population in national currency.

- Collect in National Currency the electricity service provided through the generators to the benefited population.

- Provide rental service of automotive transport equipment to entities and individuals.
